EDCO 05/21/8.64 TABLING OF FINAL IDP REVIEW 2021/ 22 & BUDGET FOR 2020/21 TO 2020/ 23 MTREF FINANCIAL YEAR

The Mayor of eDumbe Local Municipality, acting in terms of section 16 (2) of the Municipal Finance Management Act, (Act 56 of 2003), hereby table the 2021/2022 Municipal Budget and all budget related policies to Council.

After consideration Council resolved:

- 1. Approve and adopt the eDumbe Final 2021/ 2022 IDP Review.
- 2. That the IDP be submitted to all relevant structures, placed on Municipal Website and Advertised as in line with regulatory framework.
- 3. Approve the eDumbe Ward Based Plans as supporting the proposed Integrated Development Plan.
 - 3.1. That the 2021/2022 budget and Medium-Term Revenue and Expenditure Framework (MTREF) for the three year period commencing in 2021/22 financial year.
 - 3.2. That the Operational and Capital budget for the outer years 2021/22 and 2022/2023.
 - 3.3. That this budget provides for the general increase of 4.1% on Employee Related Costs and provision for the Upper Limits for Remuneration and Allowances for Councillors and Political Office Bearers. However, implementation of any staff salary increases is subject to the confirmation by the SALGBC first. Further any increase for Councillors be subject to approval by MEC for Co-operative Governance and Traditional Affairs.
 - 3.4. To note that the preparation of this budget took into consideration mSCOA Regulations and Integrated Development Plan.
 - 3.5. That the copies of the Budget be submitted to National Treasury, DPLG, DTLGA and Provincial Treasury as per the requirements of the MFMA.
 - 3.6. To approve the developed Electricity Theft By-law which will be communicated through public participation and to take note of the Budget related policies.
 - 3.7. To approve the budget funding (grants) and the proposed tariff charges.
